- 4. In terms of the aforesaid notice, Members were required to convey their assent or dissent, as the case may be, as under:
 - a. In case of Postal Ballot Form mailed to them by the Company, in prepaid envelopes addressed to me, upto 5:00 p.m. on Sunday, 27th August, 2017.
 - b. In case of remote e-Voting, votes to be cast electronically on the e-voting platform provided by Central Depository Services (India) Limited upto 5:00 p.m. on Sunday, 27th August, 2017.
 - c. I received 286 Postal Ballot Forms and 145 Members had cast their votes on the remote e-Voting platform, till 5:00 p.m. on Sunday, 27th August, 2017.
- 5. With the support of M/s. Link Intime India Private Limited, the Registrar & Transfer Agents (RTA) of the Company, the Postal Ballot Forms were scrutinized and signatures of Members were verified with their specimen signatures registered with RTA and as provided by the Depositories.
